### **NEW BUSINESS / UNFINISHED BUSINESS**

Transfer of Funds – The IDA used its line of credit to purchase land in the Oneonta Rail Yards on behalf of the Oneonta Rail Yards LDC in 2016. The CRC will now transfer approximately \$302,558.78 to the LDC, so that the LDC may reimburse the IDA for the amount used to purchase the land and the interest paid on it.

### **RESOLUTIONS**

### Authorize Transfer of Funds from CRC to LDC

RESOLUTION: AUTHORIZING THE TRANSFER OF FUNDS FROM THE COUNTY OF OTSEGO CAPITAL RESOURCE CORPORATION TO THE ONEONTA RAILYARD LOCAL DEVELOPMENT CORPORATION

WHEREAS, the Oneonta Railyard Local Development Corporation had borrowed funds from the County of Otsego Industrial Development Agency to purchase approximately 89 acres of property at the end of Roundhouse Road in the City of Oneonta; and

WHEREAS, staff from the New York State Comptroller's Office have made certain recommendations; and

WHEREAS, the Oneonta Railyard Local Development Corporation would like to pay the IDA back the funds loaned with interest for the acquisition of said parcel; now therefore be it

RESOLVED, that the Director of Finance and Administration is hereby authorized to arrange to transfer funds from the County of Otsego Capital Resource Corporation to the Oneonta Railyard Local Development Corporation in the amount \$302,558.78.

Resolution authorizing the Director of Finance for the agency to transfer funds from the CRC to the Oneonta Rail Yards LDC to reimburse the IDA for the purchase of the Oneonta Rail Yards and the interest paid on the line of credit. This resolution supersedes the resolutions approved by board members at the October 25<sup>th</sup>, 2019 board meeting regarding the transfer of funds to pay-off the line of credit.

J. Lord made a motion to approve the transfer of approximately \$302,558.78 from the CRC to the Oneonta Rail Yards LDC. D. Rowley seconded the motion and it was approved by remaining members.

There being no further business to discuss, T. Armao made a motion to adjourn the meeting. P. Kennedy seconded the motion, and the meeting was adjourned at 9:49am.
