RESOLUTIONS AND MOTIONS

Resolution Clarifying Otsego Co. Capital Resource Corporation's intent on Railyards Development and authorizing transfers to the Otsego Co. IDA

RESOLUTION CLARIFYING OTSEGO COUNTY CAPITAL RESOURCE CORPORATION'S INTENT ON RAILYARDS DEVELOPMENT AND AUTHORIZING TRANSFERS OF FUNDS TO THE OTSEGO COUNTY INDUSTRIAL DEVELOPMENT AGENCY

WHEREAS, at the January 20, 2015 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the Chief Operating Officer reminded the Board that it had decided to discuss setting up a structure within which to begin assessing OCCRC funds...consistent with its mission; and

WHEREAS, at the March 26, 2015 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the Chief Operating Officer again noted that the current deposits and pending transactions would leave the OCCRC with close to \$1 million in an interest-bearing checking account and whether the Board should reallocate and transfer some of these funds to the IDA as well as a discussion for the need for flexibility; and

WHEREAS, at the August 27, 2015 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the Chief Executive Officer presented the following Resolution for the Oneonta Rail Yards which was unanimously adopted by the Board:

A resolution to authorize the creation of an LDC or LLC to act in the real estate purchase transaction;

WHEREAS, at the December 17, 2015 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the Chief Operating Officer recommended the transfer of \$400,000 from its account into the IDA checking account to cover Project related expenses with respect to the Richfield Springs comprehensive plan and the Cooperstown comprehensive plan which was approved unanimously by the board; and

WHEREAS, at the January 28, 2016 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the OCCRC Treasurer notified the Board of the money transfer between the IDA and the OCCRC for the Cooperstown and Richfield Springs Plan; and

WHEREAS, also at the January 28, 2016 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the Board discussed the opening of a line of credit for the OCCRC; and

WHEREAS, also at the January 28, 2016 Board of Director's Meeting of the Otsego County Capital Resource Corporation, a motion was presented to the Board that the OCCRC authorize the spending to support Phase I and Phase II of the Oneonta Rail Yard Re-Development Project up to \$785,000 including NYS ESD obligation for a 50% reimbursement for a total OCCRC cost of \$392,500; and

WHEREAS, also at the January 28, 2016 Board of Director's Meeting of the Otsego County Capital Resource Corporation, the following contacts were approved by the OCCRC:

- A contract with Delaware Engineering for the Rail Yards, not to exceed \$385,000
- A contract with Elan Planning for the Oneonta Plan and housing study not to exceed \$90,000
- A contract with Clark Paterson Lee for the Rail Yards not to exceed \$95,600; and

WHEREAS, the Otsego County Industrial Development Agency used its funds to pay costs associated with the Phase I and Phase II Oneonta Rail Yard Re-Development as well as for contracts with Delaware Engineering, Elan Planning and Clark Paterson Lee for Rail Yard work; now therefore be it

D. Rowley suggested amending the resolution to transfer the funds to the Oneonta Railyard Local Development Corporation, as opposed to the IDA, and requested that the Oneonta Railyard Local Development Corporation pay off the line of credit that the IDA took out for the purchase of the Roundhouse Road Property on behalf of the LDC. The transfer of funds by the CRC to the Oneonta Railyard LDC would equal the amount owed on the letter of credit.

D. Rowley made a motion to pass an amended resolution authorizing the CRC to reimburse funds to the LDC to pay off the line of credit for the purchase of the Rail Yards. The motion was seconded by C. Gelbsman. J. Lord abstained from the vote and the amended resolution was approved by remaining board members.

Adoption of 2020 OCCRC Budget for PARIS Reporting

J. Zakrevsky provided board members with a 2020 budget for the CRC to be filed with PARIS. J. Zakrevsky requested approval to submit the budget into the PARIS system.

D. Rowley made a motion to approve the 2020 CRC budget presented. J. Lord seconded the motion, and it was approved by the remaining board members.

ADJOURNMENT

There being no further business to discuss, D. Rowley made a motion to adjourn the meeting. P. Kennedy seconded the motion, and the meeting was adjourned at 11:14am.
