Brewery Ommegang receives 27,000 visitors per year. The new visitors' center will provide facilities for brewery tours and education, product tasting, retail of merchandise and beer and meeting rooms for brewery use.

A portion of the visitors' center (approx 15% of total space) will be given over to retail of beer and merchandising. The majority of space (85%) will be used for non-retail activities.

The current small visitors tasting room needs to be re-purposed for production and is heavily space constrained given the growth potential for visitors to the brewery over the next 5-10 years.
